The concerned department should verify the filled in application form along with Photo copies of the marks cards of previous Semesters with regard to "ELIGIBILITY". The duly verified application form along with the enclosures shall be forwarded by the Chairpersons to the Office of Director, for approval of admission on or before 25-01-2023.

- As per Circular cited at reference (2) above, the SC/ST candidates within Karnataka and whose parents annual income is less than or equal to 2,50,000/- (Rupees Two Lakhs and Fifty thousand only) per annum are not liable to pay Rs. 19,090 for II year, Rs. 16000/- for III year, Rs. 15000/- for IV year B.Tech, B.Arch & Rs. 15000/- for V year B.Arch at the time of admission. However, these students shall pay the remaining fee i.e., II year Rs. 4800/-, III year-Rs.1,710/-, IV & V years-Rs.710/-, The students shall pay the fee reimbursed from the State Scholarship Portal (which is due to be paid at the time of admission) immediately to the University (UVCE). The examination fees shall be paid in full as and when the same is notified later by UVCE, Bangalore. However, the candidates whose parents' annual income is above Rs.2.5 Lakh shall pay the prescribed fees as mentioned in table above.
